*August 2 – 17, 2018*

**T**he mouth of the Amazon River is one of the most geographically complicated regions of the entire basin. It is, of course, a vast area as well, encompassing dozens of islands and enormous tracts of seasonally flooded forests bounded all around by *terra firme* forest that is, unfortunately, being steadily reduced under increasing human pressure. We will see all of this during our two-week birding swing through four select stops designed to give us a chance at finding almost all of the (many!) species of birds endemic to this region of Amazonia.

We'll start our tour at the city of Belem, capital of Para state, with some light birding in areas close to the city to get us acclimated to the weather of the Amazon and we hope to find a few specialties such as the Hooded Gnateater and Opal-crowned Manakin just to whet our appetite for some of the many range-restricted birds we are likely to find on this tour. A

chartered flight will then take us to Mexiana Island, affording fantastic views (with reasonably clear weather, of course!) of the intricate network of riverways and islands that comprise the Delta Amazonas region; Mexiana is set right at the confluence with the Atlantic Ocean and the equator line runs right through the Island. We'll spend a full day exploring the island as we search for specialties such as Blackish-Gray Antshrike, Crimson-hooded Manakin, Scaled Spinetail, White-bellied Seedeater (endemic subspecies *mexiana*) and Ruddy-breasted Seedeater which has a fairly small distribution in Brazil.



Next comes a flight west to the town of Altamira on the lower Xingu River, where construction of a massive hydroelectric dam is nearing completion and human population expansion has taken a heavy toll on the environment. Still, some productive birding on river islands and a private ranch preserving thousands of acres of tall forest will keep us busy for a few days as we search for the endemic Golden Parakeet, the strange Vulturine Parrot, Guianan Red-cotinga and a myriad of flock specialists which we may encounter along forest trails, not to mention some night birding with great chances of seeing Long-tailed Potoo, Black-banded Owl, Crested Owl and Tawny-bellied Screech-Owl!

Then we'll swing well south and east to the remote Carajas National Forest, an uplifted region where one of the largest iron-ore mines in the world is surrounded by unbroken forest. In this region, the open habitats of northeastern Brazil give way to the rainforests of lower Amazonia, with a corresponding mixture of elements in the avifauna. Impressive forested ridges surge upward from the lowland plain making for some spectacular scenery as well. This area is particularly well endowed with parrots—among the species we could see are six species of macaws

(including Hyacinth, here in rainforest habitat), the beautiful Jandaya Parakeet, the very local Pearly Parakeet, and the stunning Red-fan Parrot. A few of the other exciting bird possibilities are Brazilian Tinamou, White-crested and Rusty-margined guans, Bare-faced Curassow, Russet-crowned Crake, Rufous-necked Puffbird, Red-necked Aracari, Dusky-billed and "Carajas" woodcreepers, Curve-billed Scythebill, lots of ovenbirds and antbirds including the rarely seen Black-bellied Gnatcatcher (a gorgeous bird); the ultra-rare Black-chested Tyrant; Black-and-white Tody-Tyrant, the spectacular, endemic White-tailed Cotinga, White Bellbird (represented by the subspecies *wallacei*, known only from Carajas), and the little-known Guianan (Para) Gnatcatcher.

Not to overdo it, but it is worth mentioning that Harpy Eagle is a realistic hope in the Carajas area; if the nest is active, we may have incredible views of this bird! We should also see a variety of exciting mammals in these forests. Our forest birding will be complemented with a couple of final days in estuarine habitats east of the delta of the Amazon. Exploring this geomorphologically dynamic coastline, characterized by mangrove peninsulas crossed by tidal channels, with smaller areas of flooded saline campos and coastal *restinga* forest, we will search for Little Woodrail, Mangrove Cuckoo, Plain-bellied Emerald, among many other birds, and hope to see impressive flocks of Scarlet Ibis.

**About the Physical Requirements & Pace:** We'll be up early for breakfast every morning, then spend most mornings driving to specific sites where we'll spend time birding along roads through forest, as well as in open, *cerrado*-like habitat. The walking, whether on roads or trails, is generally easy going but some of the trails we'll be walking on will be freshly cut as some of the areas explored on this tour are far out of any known tour route. You may expect to encounter sharp stubs, tree trunks and small streams to get across on such trails. Most days will see us back to the hotel/ranch for lunch, but on a day or two we'll probably take a box lunch for more time in the field and less time driving to and from birding sites. We'll have plenty of water and other drinks with us on the bus. Afternoon birding is always much slower than morning hours, and we will offer a nocturnal outing or two to forests close to the hotel.

## Itinerary for Mouth of the Amazon and Lower Rio Xingu

**Days 1-2, Thu-Fri, 2-3 Aug. Arrival in Belem.** Most flights depart the USA on the evening of Day 1 and arrive in Belem early afternoon on Day 2. We should make it to our hotel by around 2:00 p.m., and have a nice get-together dinner at the hotel. You may have to spend the night in Miami or choose a different overnight flight coming through Brasilia, Sao Paulo or Rio. Your tour manager will be happy to help with any overnight arrangements. Night of Day 2 in Belem.

**Day 3, Sat, 4 Aug. Belem.** The city of Belem is 400 years old and the human occupation has taken its toll on the forest but a mosaic of protected areas with more than 6000 square kilometers of native habitat still stands around the city. Today we will be up early to make our way to an area on the outskirts of the city where we will spend the morning birding; our main targets will be Opal-crowned Manakin, Hooded Gnatcatcher, and the nominate subspecies of Willis's Antbird, a species with three disjunct populations. The birding is sure to be productive and there will be no shortage of great birds to set the mood for the following days. We'll have lunch and return to the hotel for a siesta and use the afternoon to visit a reserve in town and do our checklist at a restaurant near the river to enjoy our first view of the Amazon near its delta. Night in Belem.

**Day 4, Sun, 5 Aug. Belem to Mexiana Island.** The delta of the Amazon is the one place where one can fully comprehend how mighty the Amazon truly is. The river reaches its delta below the Xingu, with many islands formed by alluvial deposit and submergence of the land. Around the largest of these, Marajo, the river splits into two large streams. The northern stream is the principal outlet and threads its way around many islands, the largest of which is Mexiana. A chartered flight will take us there providing privileged views of the intricate mosaic of islands that compose the archipelago formed at the mouth of the Amazon and the immense silt-laden discharge of the river stretching far out to sea. As soon as we get our boots on the ground we will go out either by safari vehicle or by boat to explore the surrounding forests as we search for specialties such as Scaled Spinetail, Short-tailed Parrot, Blackish-gray Antshrike and the charming Crimson-hooded Manakin. We will return to our lodge for a brief siesta and go back out to explore the forest close to the lodge on foot. Night at Mexiana Island. *(Please note that chartered planes have stringent luggage limitations and we will ask all clients to bring a small bag that can be used for the one night we will spend on the island. Our main luggage will remain in storage at our hotel in Belem and we will pick it up on our way to the airport the next day.)*

**Day 5, Mon, 6 Aug. Return to Belem and Transfer to Xingu.** After a few hours birding around Mexiana Island in the morning to pick up any species we may have missed the previous day, we will fly back to Belem, affording us another opportunity to view the Amazon delta. We will then swing by our hotel and collect the bulk of our luggage and catch a flight to the city of Altamira where we will transfer by bus to the bank of the Xingu River and do a little birding on that great tributary of the lower Amazon en route to the private ranch where we will be staying for the next 3 nights. Night at private ranch.

**Days 6-7, Tue-Wed, 7-8 Aug. Xingu River.** With its headwaters in the *cerrado* of Mato Grosso, the Xingu River flows north for more than twelve hundred miles before reaching the Amazon. This great Amazonian river has been chosen by the Brazilian government as the location for the third largest hydroelectric power plant in the world; construction is in its final stages. The massive influx of people associated with construction has brought great pressure from the logging and agricultural industries, which we will witness first-hand, but the private cattle ranch where we'll be based still holds more than 100,000 hectares of preserved forest. This area is far away from any tourist routes and very little research has been done there, so our visit will surely contribute to the documentation of this under-studied region of the Amazon. This is one of the best places in the world to see the spectacular Golden Parakeet and we will have two full days to look for this rarely seen Brazilian endemic. In the process, we are likely to find a large number of other remarkable species, such as the bizarre Vulturine Parrot, Guianan Red-cotinga, Wing-banded Antbird, the recently split Xingu Scale-backed Antbird, and we will surely do some night-birding to look especially for Long-tailed Potoo, Black-banded and Crested owls, and Tawny-bellied Screech-Owl. Nights at private ranch.

**Day 8, Thu, 9 Aug. Xingu River to Belem.** Once again, we will be up before sunrise for a last morning of birding around the private ranch where we will be lodged. After an early lunch and a brief siesta, we will make our way back to the town of Altamira and onto our flight back to Belem. We will spend the night in Belem in order to connect with an afternoon flight to either Maraba or Carajas; our destination will be subject to flight availability. Night in Belem.

**Day 9, Fri, 10 Aug. Belem to Carajas.** Our flight departs from Belem in the afternoon, so we will take advantage of the morning to visit a reserve near the hotel in search of species such as Red-necked Aracari, Plain-crowned Spinetail, Chestnut-backed Antshrike and the endemic Buff-browed Chachalaca. We will then transfer to the airport where we will have lunch and board our flight to either Maraba or Carajas (subject to flight availability. If we need to fly to Maraba, we will drive from there to Carajas.). We will do a little afternoon birding in the Carajas National Forest before reaching the hotel. With a good dose of luck, we may even find a Black-bellied Gnatcatcher. Night in Carajas.

**Days 10-13, Sat-Tue, 11-14 Aug. Carajas.** We will have four full days to search for the many species of birds endemic to lower Amazonia inhabiting the forests around Carajas. We will be out early every morning to be in place as the forest awakens with the dawn chorus. This area, between the Xingu and Tocantins rivers, is near the eastern edge of the vast rainforests that stretch to the base of the Andes far to the west. It is also on the fringe of the drier forests of far eastern Brazil. The avifauna is understandably complex and relatively poorly known.

A partial listing of the specialties we may see includes Russet-crowned Crake, Gray-bellied Goshawk (quite rare, as usual), Harpy Eagle, the beautiful White-crested Guan, Bare-faced Curassow, Dark-winged Trumpeter, Hyacinth Macaw, Jandaya and Pearly parakeets, Vulturine and Red-fan parrots, Pavonine Cuckoo, Amazonian Pygmy-Owl, Scissor-tailed Nightjar, Blue-cheeked Jacamar (formerly considered the subspecies *cyanicollis* of Yellow-billed Jacamar), Rufous-necked Puffbird, Red-necked Aracari, Amazonian Barred Woodcreeper, Curve-billed Scythebill, Glossy Antshrike, Long-winged Antwren (distinctive subspecies *paraensis*), Black-bellied and Chestnut-bellied gnatcatchers (secretive but likely to be seen well), White-tailed Cotinga, White Bellbird (isolated, endemic subspecies *wallacei*), Opal-crowned Manakin, Black-and-white Tody-Tyrant, Black-chested Tyrant (very rare, but let's get it anyway), Snethlage's Tody-Tyrant, Guianan Gnatcatcher (likely to be split as Para Gnatcatcher), and Yellow-shouldered Grosbeak. Of course, we will see and/or hear some 250 other birds which we certainly will not neglect as we seek out the less common species! Nights in Carajas.

**Day 14, Wed, 15 Aug. Carajas to Belem and on to Salinopolis.** Our flight to Belem leaves around lunch time, giving us the best part of the day to bird in Carajas before packing up and heading back to the airport. From there we will drive to the coastal town of Salinopolis where we will settle down for our final couple of days. Night in Salinopolis.

**Day 15, Thu, 16 Aug. Birding the Salgado Paraense.** The coastal region of the state known as “Salgado Paraense” lies east of the delta of the Amazon and has been neglected by ornithologists and birders for years, yet some recent visits to the area by researcher Alex Lees have produced some interesting records of Pinnated Bittern, Black Rail, Blue-winged Teal, Little Woodrail, and Mangrove Cuckoo, not to mention a relative abundance of Scarlet Ibis which we will be sure to encounter on a boat outing or two. This will be a productive and fun day of birding to wrap up our tour and we’ll enjoy great food and birding in the resort town of Salinopolis. Night in Salinopolis.

**Day 16, Fri, 17 Aug. Departure.** After a relaxed breakfast we will pack up and head straight to Belem’s international airport where participants will be able to connect with afternoon flights departing to the US. Boa Viagem!

## About Your Guides

**Marcelo Padua** was born in Belem at the mouth of the Amazon River. Growing up he spent his free time at his uncle's farm in an Amazon rainforest reserve observing everything from insects to mammals and birds. Marcelo began studying English at an early age and attended high school in Middletown, Pennsylvania in a student-exchange program. He is remarkably fluent and even taught English for a couple of years back home in Brazil. Following university in Rio de Janeiro, Marcelo transferred to law school in Cuiaba, but working as an English-speaking naturalist guide during school holidays soon made it clear to him that birding was much more than a hobby! With just a year to go for his bar exam, he turned his back on the law to hang out his shingle as a birding guide. He met Bret Whitney in 2005, and embarked on a full-time guiding career with Field Guides in 2009.

With his great sense of humor, impeccable organizational skills, and love of seeing birds, Marcelo has quickly become a reference for birding in Brazil, spending over 200 days each year in the field. A warning: Watch out if he sees displaying manakins of any kind! Marcelo makes his nest at the crossroads of the Pantanal and the Amazon in Cuiaba with his wife, Ana.

**Jay VanderGaast** was introduced to birding by his father, and his obsession with birds was evident by age seven when he memorized the plates in Peterson's eastern field guide. He went on to earn a B.S. in biology at university and briefly contemplated a career in research, but two years on the mosquito-infested arctic tundra watching ptarmigan do little other than occasionally getting eaten by Gyrfalcons soon put an end to that plan! Instead, he strapped on a backpack and a pair of bins and began roaming the world in search of birds.

His travels eventually led him to Costa Rica, where he stumbled into a job as a birding guide at Rancho Naturalista Lodge. Amazed that he was actually getting paid to watch birds, he jealously guarded his position there for six years. His career with Field Guides coincided with the dawn of the new millennium (if you believe that began in 2000!), and since then he has guided more than 100 tours on several continents.

When he's not on tour, Jay's native habitat is his home near Montreal, where he lives with his partner, Annie, and their children—daughters Ariane and Elodie, and son Noah.

## Other Things You Need to Know

**TOUR MANAGER:** The manager for this tour is Ruth Kuhl. Ruth will be happy to assist you in preparing for the tour. If you have any questions, please don't hesitate to call her!

**ACCOMMODATIONS:** We will be staying in comfortable hotels or lodges on all nights.

**DOCUMENTS:** A current passport valid for 6 months is necessary for US citizens to enter Brazil. In addition, you will need a visa to enter Brazil. Our office will forward you visa application instructions.

If you are not a US citizen, please check with the Brazilian consulate nearest you for entry requirements. Information about consulates and entry requirements is generally available online or you can contact us and we will be happy to look this up for you. Passports should have an adequate number of blank pages for the entire journey. Some countries require a blank page for their stamp and as a precaution it is best to have one blank page per country you will visit or transit.

**VACCINATIONS:** Yellow Fever is widespread in many parts of Brazil, and we recommend all travelers to Brazil be vaccinated against the disease. Please check <https://wwwnc.cdc.gov/travel/yellowbook/2018/infectious-diseases-related-to-travel/yellow-fever-malaria-information-by-country/brazil - seldyfm879> for the current CDC information and consult with your physician about whether the vaccine is appropriate for you (there are contraindications for some individuals).

**AIR ARRANGEMENTS:** Field Guides is a full service travel agency and your tour manager will be happy to assist you with flights to join this tour. Field Guides does not charge a service fee for these services to clients booking a tour. However, we understand that tech-savvy clients often prefer to shop online or that you may wish to use mileage to purchase tickets. Regardless of which method you choose, your tour manager will be happy to provide assistance regarding ticket prices and schedules, along with rental cars and extra hotel nights as needed.

Please be sure to check with your tour manager prior to purchasing your ticket to make sure the flights you have chosen will work well with the tour itinerary and that the tour is sufficiently subscribed to operate. Once purchased, most airline tickets are non-refundable and carry a penalty to change. Field Guides cannot be responsible for these fees.

**Also, it is imperative that we receive a copy of your comprehensive flight itinerary—including any and all flights not covered in the tour fee—so that we may track you in the event of missed connections, delays, or other mishaps.**

**LUGGAGE:** Please be aware that many airlines have recently modified their luggage policies and are charging additional fees for checked bags. Updates could easily occur before your departure, so you may wish to contact your airline to verify the policy. Additional charges for bags on any flights, whether these are covered by the tour fee or not, will be the client's responsibility.

**TOUR INCLUSIONS/EXCLUSIONS:** The **tour fee** is \$6975 for one person in double occupancy from Belem. It includes all lodging from Day 2 through Day 15, all meals from dinner on Day 2 through dinner on Day 15 (breakfast is included on Day 16, if your flight departure time allows for it), all ground transportation, all internal flights (chartered and scheduled), entrance fees, tips for baggage handling and meal service, and the guide services of the tour leader(s).

The above fees do not include your airfare to and from Belem, airport taxes, visa fees, any checked or carry-on baggage charges imposed by the airlines, any alcoholic beverages, optional tips to local drivers, phone calls, laundry, or other items of a personal nature.

The **single supplement** for the tour is \$450. If you do not have a roommate but wish to share, we will try to pair you with a roommate from the tour; but if none is available, you will be billed for the single supplement. Our tour fees are

based on double occupancy; one-half the cost of a double room is priced into the tour fee. The single supplement is calculated by taking the actual cost of a single room and subtracting one-half the cost of a double room (plus any applicable taxes).

**TOUR REGISTRATION:** To register for this tour, complete the enclosed Registration/Release and Indemnity form and return it with a **deposit of \$700** per person. If registering by phone, a deposit must be received within fourteen days, or the space will be released. **Full payment** of the tour fee is due 120 days prior to departure, or **by April 4, 2018. We will bill you for the final payment at either 120 days or when the tour has reached sufficient subscription to operate, whichever date comes later.** Since the cost of your trip insurance and airline tickets is generally non-refundable, please do not finalize these purchases until you have received final billing for the tour or have been advised that the tour is sufficiently subscribed to operate by your tour manager.

**TOUR LIMITS:** Our limits are firm and we don't exceed the limit by one to accommodate a couple when only one space remains open. However, on occasion, we will send along a guide in training on a tour. In these cases one seat in the van or bus will be taken by the guide in training. Our guides will have a rotation system within the vehicle so that clients share the inconvenience equally. We hope this minor inconvenience will be more than offset by the advantages of having another guide along.

**SMOKING:** Almost all of our clients prefer a smoke-free environment. If you smoke, please be sensitive to the group and refrain from smoking at meals, in vehicles, and in proximity to the group on trails and elsewhere.

**CANCELLATION POLICY:** Refund of deposit and payment, less \$100 handling fee, will be made if cancellation is received up to 120 days before departure. If cancellation occurs between 119 and 70 days before the departure date, 50% of the tour fee is refundable. Thereafter, all deposits and payments are not refundable.

This policy only applies to payments made to Field Guides for tour fees (and any services included in those fees). Airline tickets not included in the tour fee and purchased separately often carry penalties for cancellation or change, or are sometimes totally non-refundable. Additionally, if you take out trip insurance the cost of the insurance is not refundable so it is best to purchase the policy just prior to making full payment for the tour or at the time you purchase airline tickets, depending upon the airlines restrictions.

The right is reserved to cancel any tour prior to departure, in which case full refund will constitute full settlement to the passenger. The right is reserved to substitute another guide for the original one. Where this is necessary, notification will be given to tour members, and they will have the right to cancel their participation and receive a full refund.

**TRIP CANCELLATION & MEDICAL EMERGENCY INSURANCE:** We strongly recommend you consider purchasing trip cancellation (including medical emergency) insurance to cover your investment in case of injury or illness to you or your family prior to or during a trip. Because we must remit early (and substantial) tour deposits to our suppliers, we cannot offer any refund when cancellation occurs within 70 days of departure, and only a partial refund from 70 to 119 days prior to departure (see CANCELLATION POLICY). In addition, the Department of State strongly urges Americans to consult with their medical insurance company prior to traveling abroad to confirm whether their policy applies overseas and if it will cover emergency expenses such as a medical evacuation. US medical insurance plans seldom cover health costs incurred outside the United States unless supplemental coverage is purchased. Furthermore, US Medicare and Medicaid programs do not provide payment for medical services outside the United States.

When making a decision regarding health insurance, Americans should consider that many foreign doctors and hospitals require payment in cash prior to providing service and that a medical evacuation to the United States may cost well in excess of \$50,000. Uninsured travelers who require medical care overseas often face extreme difficulties. When consulting with your insurer prior to your trip, please ascertain whether payment will be made to the overseas healthcare provider or whether you will be reimbursed later for expenses that you incur.

US citizens will receive from us a brochure regarding optional tour cancellation/emergency medical insurance. Our agent, CSA, will insure for trip cancellation and interruption, medical coverage, travel delay, baggage loss and delay, 24-hour accident protection, and emergency medical transportation. If you purchase the insurance when making final payment for the tour, and cover all non-refundable parts of the trip (including any non-refundable flights), pre-existing conditions are covered. The CSA brochure includes a contact number; you may also purchase your CSA policy on-line by visiting our website at <https://fieldguides.com/travelinsurance.html> and clicking the link to CSA. Please note, once the insurance is purchased it is non-refundable, so please check with your tour manager prior to making the purchase to assure the tour will operate as scheduled. Citizens of other countries are urged to consult their insurance broker.
